

# Membership

The membership of Waqaf An-Nur consists of Ordinary Member, Corporate Member and Honorary Member as enumerated below:

## 1 Ordinary Member

Consists of Ordinary Member (Individual) and Ordinary Member (Corporate):

### i) Ordinary Member (Individual)

Muslim individuals of not less than 18 years old who apply and are accepted by the Board of Directors to be Ordinary Members.

The Registration fee and Annual Membership fee payable to Waqaf An-Nur are as follows:

Registration fee – RM50.00 (Ringgit Malaysia Fifty Only) payable upon registration;

Annual fee – RM100.00 (Ringgit Malaysia One Hundred Only).

Ordinary Membership is non-transferable and membership ceases upon the member's demise and/or upon the dissolution of Waqaf An-Nur.

### ii) Ordinary Member (Corporate)

Companies or commercial entities based on Syaria laws which are Muslim owned and from the following categories:

- a) Sole proprietorships or joint ownerships registered under the Trade Registration Act, 1956 or Partnership Act, 1976 in Malaysia;
- b) Businesses registered under the Company Act, 1965 in Malaysia;
- c) Businesses licensed by the Federal, State or Local Government in Malaysia or by any such authority in Malaysia provided always that Waqaf An-Nur is empowered to determine, from time to time, the status of the applicant company and that it is approved by the Board of Directors to be a member; or
- d) Cooperatives registered under the Cooperative Societies Act, 1948 and organisations, associations and other non-governmental organisations (NGOs) established under the Societies Act (Amended), 1966.

The Registration fee and the Annual Membership fee of Ordinary Member (Corporate) payable to Waqaf An-Nur are as follows:

Registration fee – RM250.00 (Ringgit Malaysia Two Hundred Fifty Only) payable upon registration.

Annual fee – RM1,000.00 (Ringgit Malaysia One Thousand Only).

## 2 Corporate Member

Consists of Fiddhah Corporate Member and Zahab Corporate Member.

### i) Fiddhah Corporate Member:

Registration fee – RM250 (Ringgit Malaysia Two Hundred Fifty Only) payable upon registration;

Annual fee – RM10,000.00 (Ringgit Malaysia Ten Thousand Only) payable in one lump sum as a one-off payment in the first year of membership.

An Ordinary Member (Corporate) who has paid a cumulative Annual Fee totalling RM10,000.00 (Ringgit Malaysia Ten Thousand Only) may, from time to time, be identified for invitation be Fiddhah Corporate Member.

**ii) Zahab Corporate Member**

Registration fee – RM250.00 (Ringgit Malaysia Two Hundred Fifty Only) payable upon registration;

Annual fee – RM100,000.00 (Ringgit Malaysia One Hundred Thousand Only) payable in one lump sum as a one-off payment in the first year of membership.

### **3 Honorary Member**

Consists of Honorary Member (Ex Officio) and Honorary Member (Individual):

**i) Honorary Member (Ex Officio)**

Appointed by virtue of holding office in the public or private sector or any charitable institution or any non-governmental organisation (NGO) who may, from time to time, be determined for the purpose of being invited by the Board of Directors; and also individuals holding positions described in (i) to (x) below who are hereby appointed ex officio Honorary Members for the duration they hold the positions so stated:

- i) Chief Executive,

- ii) Director, Religious Department, Johor;
- iii) Mufti, Johor
  
- iv) Chief Operating Officer,  
Johor Corporation;
- v) Deputy Mufti, Johor;
- vi) Managing Director,  
Kulim (M) Berhad;
- vii) Managing Director,  
KPJ Healthcare Berhad;
- viii) Managing Director,  
Johor Land Berhad;
- ix) Managing Director,  
Sindora Berhad; and
- x) Johor Waqaf Group Officer.

**ii) Honorary Member (Individual)**

Individuals who settle the payment of their fees totalling RM1,000.00 (Ringgit Malaysia One Thousand Only) in one-lump sum on cash basis or Ordinary Members (Individual) who pay their annual fee on a cumulative basis may, with the approval of the Board of Directors of Waqaf An-Nur, have their memberships converted from Ordinary Member (Individual) to Honorary Member (Individual).
